

**READING TOWNSHIP BOARD OF SUPERVISORS
SPECIAL MEETING
JUNE 7, 2018**

A special meeting of the Reading Township Board of Supervisors was held at the Township Building and called to order at 3:30 p.m. by Kevin Holtzinger, Chairman. Gary Sauble and Marcia Weaver were present with Chairman Holtzinger presiding. Also in attendance was Adrienne Capps representing Vulcan Materials.

The purpose of the special advertised meeting was to read the bids received for aggregate and to rectify the error in bid reading from the May 21, 2018 Board of Supervisors Meeting.

Concern was expressed regarding the validity of the prices received from York Building Products. Chairman Holtzinger, using a speaker phone so all in attendance could hear the conversation, contacted Mike Gemmill at York Building Products. Chairman Holtzinger asked for clarification on the prices quoted in column 6 of the bid sheet labeled "Deliver to Township". Mr. Gemmill stated that normally column 6 on a MS-963 form is for FOB pricing and while the bid sheet did in fact state "Deliver to Township", his company quoted FOB pricing. Chairman Holtzinger asked if he would still honor the prices provided on the submitted bid for the "Deliver to Township" pricing. Mr. Gemmill stated he would not honor those prices.

After a time of discussion, Ms. Weaver made a motion to reject the entire bid from York Building Products due to the error in pricing and their unwillingness to honor the bid prices quoted. Mr. Sauble seconded the motion; motion carried unanimously.

Based on the remaining three bidders for aggregate, the bids were awarded as follows:

On a motion by Mr. Sauble and a second by Ms. Weaver AASHTO #1, AASHTO #3, AASHTO #57, PA 2A SUB-BASE and TYPE 2 ANTI-SKID is awarded to Vulcan Construction Materials at the above listed prices per ton. Motion carried unanimously. On a motion by Mr. Sauble and a second by Ms. Weaver R4's is awarded to Kinsley Materials at the above listed price per ton. Motion carried unanimously. Ms. Kimberly Beard, Reading Township Secretary/Treasurer to notify all bidders of the results.

ADJOURNMENT

There being no further business, the meeting adjourned at 4:12 p.m. on a motion by Mr. Sauble, seconded by Ms. Weaver, motion carried unanimously.
